### **1 Your personal information**

1.1 When you register on our Website, we may ask you to provide us with certain personal information, such as your name, email address, country of residence and a password (where a login has been provided) ("Personal Information"). We may also collect other information, including, but not limited to, the URL you came from, IP address, your browser type, country of residence, and the pages of our Website that you viewed.

### **2 Acceptance of terms**

### **3 Use of your information**

3.1 We may use the information that you provide or that we collect for the following purposes:

3.1.2 to register you with Secret Files from World Wars to Cold War;

3.1.3 to contact you about related Taylor & Francis products;

3.1.4 to provide any services or information you have requested;

3.1.5 to ensure that content from our Website is presented in the most effective manner for you and for your computer;

3.1.6 for detecting and protecting against error, fraud or other criminal activity;

3.1.7 in any other way as described to you at the time of collection of your Personal Information;

## 4 Disclosure of your information

4.1 We may give information about you to the following third parties, who may use it for the same purposes as set out above:

4.1.1 to agents and employees of Informa to administer any accounts, products, and services provided to you now or in the future;

4.1.2 to agents who profile your data so that we may tailor the goods/services we offer to your specific needs;

4.1.3 to anyone to whom we transfer or may transfer our rights and duties under our agreement with you;

4.1.4 if we have a duty to do so or if the law allows us to do so. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction;

4.1.5 to third parties who will help process or administer Informa services.

## 5 Cookies
